
Marloth Park Visitors rules and Regulations

You have now entered into a Wildlife Conservation Area

Critical Applicable Road Rules:

- **No speeding:** Tarred Roads Max -50km/h; Sand Roads Max – 30 km/h
- **No passengers** allowed on Tailgates/ side steps/ window-cills/ Roof of car while driving
- **No unlicensed/under aged** person to drive any vehicle
- **No children** allowed on the **drivers** lap
- **No Drinking and driving**
- **No vehicles on park land** (no short cuts)

Regulations applicable to any one entering and staying in Marloth Park

- **No loud noise at any time** – Music, conversation, screaming, revving of vehicles
- **No noise after 18H00** on any day of the week
- **No fireworks** – Fire hazard
- **No domesticated pets** – they kill the natural animals or cross breed
- **No Spotlights** to be used for animal viewing from cars or property
- **No cutting down or removing** of vegetation and trees
- **No open Fires** – Only in designated fire places
- **No littering** of any sort as it kills our animals or they get entangled
- **No drones allowed** – lets respect each other's privacy and the animals
- **No discharging of fire arms** – Except for self-defence as a last resort
- **No hand feeding of animals** – These are wild animals and they can hurt you (No maize or bread. Purchase proper animal feed at the local shops)
- **No walking/cycling** between 18H00 – 06H00 for your own safety as predators can get through the fence from time to time
- **No off road bikes or quad bikes** allowed to be operated anywhere in the park area
- **No Building/Construction** work between Saturday 12H00 till Monday 07H00

General curtesy request to all in Marloth

Reduce your speed even further after dark as allot of animals are more active at night and on the roads. This is to prevent you damaging your vehicle and to prevent you accidentally killing our animals

Place all your garbage in black refuse bags and remove them after your stay and drop them at the entrance Agates dump site on your way out

Disturbances

If any Noise Disturbance complaint has been received by any Security Company your will be fined. First Call Out R350; Second Call Out R2500 & Third Call out you will be asked to leave Marloth Park with the assistance of the SAPD
